HISTORIC BREVARD

HISTORICAL FACTS PROVIDED BY THE BREVARD COUNTY HISTORICAL COMMISSION

The Georgiana Methodist Church in Merritt Island was constructed by volunteer labor out of wood that was brought down the Indian River by sailboat from St. Augustine and carried by hand by workers from the river to the construction site. The first service was held on Thanksgiving Day in 1886. From 1927 to 1929 it had a female pastor.
