#### HISTORIC BREVARD

The Banana River Air Force Station, which later became Patrick Air Force Base, was commissioned in 1940, deactivated in 1947, and transferred to the Air Force in 1949. By 1942, 1,500 service persons and several hundred civilians were employed there, providing economic stimulus to the surrounding communities.
