HISTORIC BREVARD

Cattle provided the most common livelihood in the period immediately following the Civil War, and large herds roamed freely, intermingling with cattle from neighboring herds in the western part of the County. Cross-branding of calves by mistake was a common problem and cattle theft by deliberately altering brands was also very common, leading to a full-fledged range war in the late 1860s to early 1870s.
