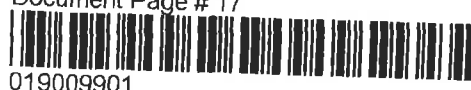

WHEREAS, Agent Don N. Reynolds has this day made complaint before me, Judge of the Circuit/County Court in and for Brevard County, Florida, and reviewed with this Court an Affidavit for Search Warrant, stating that affiant has reason to believe and does believe that certain premises and curtilage, located in Brevard County, Florida, described as follows:

The target of this search warrant is a single story apartment, located at 20 Circle Avenue #1, Melbourne, Brevard County, Florida. To arrive at the target, 20 Circle Avenue #1, Melbourne, Brevard County, Florida, one would begin at the intersection of Brevard Drive and Babcock Street. One would travel north on Babcock Street approximately .22 miles to the intersection with Circle Avenue. One would turn right (east) onto Circle Avenue and travel approximately .05 miles to the target of this search warrant 20 Circle Avenue #1, Melbourne, Brevard County, Florida. 20 Circle Avenue #1, Melbourne, Brevard County, Florida is located on the north side of Circle Avenue. The number 20 is clearly posted on the southeast corner of the building.

20 Circle Avenue #1 is further described as a one story single multifamily apartment building. The structure is white in color with pink trim. The front door of 20 Circle Avenue #1, Melbourne, Brevard County, Florida faces to the east. The south side of the building 20 Circle Avenue #1, Melbourne, Brevard County, Florida and faces toward Circle Avenue. One must enter a common breeze way dividing the apartment buildings of 20 Circle Avenue, Melbourne, Brevard County, Florida and 22 Circle Avenue. 20 Circle Avenue #1, Melbourne, Brevard County, Florida is the first apartment on the left (west) once one enters the breezeway dividing the buildings.

There is now being kept in, on, at or within said premises or curtilage thereof, the only computer in the residence described as being gray/black desk top home computer that contains information which would support and establish the involvement of Brandon Lee Bradley in the commission of felony crimes, to wit: First Degree Premeditated Murder, contrary to Section

782.04(1)(a)1, Florida Statutes, First Degree Felony Murder, contrary to Section 782.04(1)(a)2.d., Florida Statutes, and Robbery with a Deadly Weapon, contrary to Section 812.13(2)(a) Florida Statutes, and would establish that said crimes have been committed in Brevard County, Florida.


The Court has interviewed the Affiant, and it appears that he is a responsible and reputable person, employed as a law enforcement officer as set forth in the Affidavit. The Court has considered the Affidavit, which is herein incorporated by reference, and is satisfied to the existence of the facts as set forth therein, and finds that said facts do establish and constitute probable cause for the issuance of a Search Warrant for the above described residence.

NOW, THEREFORE, YOU or either of you, with such lawful assistance as may be necessary, are hereby commanded in the name of the State of Florida, in the daytime or nighttime, or on Sunday, under exigent circumstances to enter and search the aforesaid **premises and curtilage** herein specified, and including all vehicles located within the curtilage, or any persons on the premises or curtilage reasonably believed to be engaged in or connected with said illegal activity, and if the same or any part thereof be found, you are hereby authorized to seize and secure the same.

You are further commanded to prepare, at the time and place of seizure, a full and true list or inventory of all things seized, and to deliver a copy of this inventory along with a copy of this warrant to the person in charge of the premises, or in the absence of such person, to leave said copies on the premises.

You are further commanded forthwith to bring all property seized and any person arrested before the Circuit/County Court in and for Brevard County, Florida, to be dealt with according to law, and to make a return of said Warrant with a copy of the inventory duly attached thereto to said Court, properly verified by Affidavit according to law, within ten (10) days of the execution of this Warrant.
