## HISTORIC BREVARD

The meteoric growth of the population during the 1950's as a result of the burgeoning space program caused an acute housing shortage that saw many newcomers, even space workers, finding shelter wherever they could. In 1959 construction began on a 999 home Capehart Project that exceeded the total civilian construction in the County that year by nearly \$5,000,000.
