## ORDER REGARDING PET SCAN PROCEDURE

THIS CAUSE having been considered by this Court pursuant to the Defendant's request and the Court, having been advised in the premises, finds as follows: Counsel for the Defendant has represented to this Court that a PET Scan examination has been ordered by a licensed physician and is scheduled to be performed on the Defendant on December 20, 2013 at 7:30am in Rockledge, Florida. It is therefore:

ORDERED AND ADJUDGED that the John E. Polk Correctional Facility, 211 Bush Blvd., Sanford, Fl., the Brevard County Sherriff's Office and any temporary holding facility shall follow as closely as possible the protocols set out in this order, including not serving Mr. Bradley food or beverages or caffeine, except for water as requested, after 12:00am on Friday, December 20, 2013. Mr. Bradley will be permitted to have food and beverages as soon as practicable following the administration of his PET scan. It is further:

**ORDERED AND ADJUDGED** that during the PET Scan procedure Mr. Bradley shall have his hands unshackled to the extent requested by the Doctors and technicians performing the test. It is further

ORDERED AND ADJUDGED that, following the PET Scan imaging, the Polk Correctional Facility medical staff shall collect a urine sample from Mr. Bradley, before any medications are administered to him, within eight hours following the PET Scan

examination, and shall preserve the sample until and the chain of custody until it is picked up at the jail by an investigator with the Office of the Public Defender, 18<sup>th</sup> Judicial Circuit. It is further:

ORDERED AND ADJUDGED that the PET Scan imaging data shall be made available to Dr. Joseph Wu as soon as they can be transmitted to him; However, no one associated with Rockledge MRI & PET Imaging Center will divulge any results, records or information regarding this test to anyone not authorized by defense counsel for Mr. Bradley. This information will remain strictly confidential to Mr. Bradley and his defense team until such time as that information is disclosed by them, or Ordered disclosed by this Court.
