MR. BROWN: How close did you follow the case?

JUROR NUMBER 93: Oh, heck, no, I was out of control and the best thing -- you know, I wasn't

happy about it at the time but it was probably the best thing that ever happened to me.

MR. BROWN: Would it Affect you at all sitting as a juror?

JUROR NUMBER 93: No, not at all.

MR. BROWN: Thank you. Rest of that front row? Number 102.

(Thereupon, the proceedings were previously transcribed.)

MR. BROWN: And Number 116.

JUROR NUMBER 116: I've got a brother who's been arrested multiple times for DUI, felony DUI. He served five years. There is something that a few years ago I was friends with a lady, a local person here and she was murdered and I went to her funeral and that was worse than anything I had ever -- I wasn't that close, I wasn't that close of a fried to her but I went and I saw all of her siblings and her elderly mother, you know, and I answered honestly and truthfully about all the things that you guys asked me here in this, but I'd have to be honest in saying, you know, being and seeing what that's like from that other side, I have to be honest and tell you that that would make me sympathize more with the victim

and the families of the victim and I don't -- and I
do take this seriously and I'm not saying that
lightly because I think it's important for you to

MR. BROWN: Okay. We'll talk about that a little bit because I think it's certainly a natural feeling to sympathize and I don't think we would be human beings if we didn't sympathize with the family of somebody who was hurt and was murdered. I mean, that's just -- that's kind of what makes us human beings as opposed to some of the lower forms of life on the planet. The key is having that sympathy for them and for the pain and suffering, does that (unintelligible) the State from deciding whether this defendant is guilty or not and what his potential sentence may be?

JUROR NUMBER 9: Yeah, I can see the guilt or innocence part, I mean, because she -- I don't know what happened, (unintelligible) really don't have proof that he did that, but I think when you talk about -- you guys had mentioned earlier about the mitigating circumstances, I think just being on that other side, you know, and I've been -- I don't know if you want to know what case it was but it was fairly recent, it was in the past few years, that

THE COURT: Response from the State.

MR. BROWN: Judge, I think that's entirely within your discretion.

THE COURT: Here's -- I'm not going to do a whole other voir dire with individual panels, I'm going to be skeptic to do that because we have spent lots of time with each individual. We got -- I allowed you to get into a lot more subjects than what was agreed to what I said. So, knowing that those precautions are taken, does that give you comfort?

THE COURT: Just so you know, it would take a court order to have your names and information accessible and I just want you to know that. So, that wouldn't be something that would happen likely. Okay. I've never entered one of those orders yet just so you know. So, I don't expect that -- I mean, there's never an ever when it comes to court but it would require a court order. Everyone here takes that very seriously.

MR. BROWN: Number 96?

JUROR NUMBER 89: Yes.

JUROR NUMBER 96: Yes, sir.

THE COURT: 102?

JUROR NUMBER 102: Yes.

MR. BROWN: 105?

JUROR NUMBER 105: It would be the hardest decision in my life, I can make it. JUROR NUMBER 126: I've already said I could do it, but I want to ask the Judge a question. You made a good decision about everybody standing up when they give their answers, I think that was a good decision because I can't hear anything now and I don't know whether I'm supposed to hear what everybody is saying.

THE COURT: You don't think you would have any problems with that?

JUROR NUMBER 9: I would have no problem. I mean, the evidence either says you're guilty or not guilty, that's understandable, but when I --

THE COURT: Okay. But let me walk you through this.

JUROR NUMBER 9: Okay.

THE COURT: So, then your concern is the penalty phase?

JUROR NUMBER 9: I'm concerned with the mitigating circumstances. I believe that just knowing what's that like for a victim's family, I feel like that I would have a hard time even looking at anything like -- they had asked me like if there was something like maybe abuse in the defendant's past or if there was like testimony from a psychologist or if like a brain scan, brain damage, he would -- it would be very hard to even -- I think that would lessen, you know, how much that I would weigh that, you know, and how much like when we were in the penalty phase.

THE COURT: Okay. The other day when we talked about the process to do that you, have the aggravating circumstances.

JUROR NUMBER 9: Yes.

THE COURT: And the State would present

evidence as to that.

JUROR NUMBER 9: Yes.

THE COURT: You have the mitigating circumstances and the Defense would present evidence to that.

JUROR NUMBER 9: Yes.

THE COURT: Then you go through a weighing process.

JUROR NUMBER 9: Um-hmm.

THE COURT: It's up to you to decide how much weight to give --

JUROR NUMBER 9: Give that.

THE COURT: -- any of the aggravating circumstances, any of the mitigating circumstances.

JUROR NUMBER 9: Yes.

THE COURT: And then what we ask you to do is whether you can consider both possible penalties.

It's a process that you we ask you to participate in, do you think you can participate in that process and then -- I mean --

JUROR NUMBER 9: I feel like that I can participate in the process, but I do think that I need to be honest that that experience would be lurking around in there and I would remember that and I would say yes, that would affect the way, the

way -- it might affect some of the decisions I would make, yes.

THE COURT: Well, there will -- I anticipate there's going to be what's call victim impact statements.

JUROR NUMBER 9: Yes.

THE COURT: Did we talk about those with you the other day?

JUROR NUMBER 9: I don't think you talked about that, no.

THE COURT: Victim impact statements would be statements from the family or -- such as family, friends about how the death of Barbara Pill affected them.

JUROR NUMBER 9: Um-hmm.

THE COURT: The instructions will tell you that you can't consider victim impact statements as aggravating.

JUROR NUMBER 9: Okay.

THE COURT: But you will hear those. It's part of the process by law that victims are allowed to give that statement. How would you feel about -- you can't -- you can't consider those to be aggravating, do you think you would consider those to be aggravating?

JUROR NUMBER 9: I would do what, I would do what you told me to do but I just believe that all the sides each know that I had some strong feelings about that case and, you know, that I knew the people involved and. I would try my best to do what you said, yes.

THE COURT: Okay. Because you're kind of giving us mixed signals. You're saying I can do what -- I can follow your instructions, Judge.

JUROR NUMBER 9: Yes.

THE COURT: You know, people do come in here with other things that have happened in their life.

JUROR NUMBER 9: Um-hmm.

that. Like the one -- I mean, the older you are the more decisions normally you have to make and the more life experiences you have. So, we can expect you not -- we don't expect you to be here and not have had some things happen in your life that affected you. What we ask you to do when you come here is to follow my instructions, apply the law to your decision making process.

JUROR NUMBER 9: Okay.

THE COURT: And follow those rules.

JUROR NUMBER 9: Okay.

THE COURT: Now, if you say look, Judge, because of what's happened, I'm going to be bias in favor of the State in my decision making, that's one thing. If you say look, I've had this experience, I just want everyone to know but, Judge, I can follow your laws, that's another thing.

JUROR NUMBER 9: Okay.

THE COURT: So where do you think you are?

JUROR NUMBER 9: I'm closer to the second one
that I can follow your laws, but I did believe that
that is something that needs to be considered in
looking at things.

THE COURT: Okay. Because you answered that in the response to -- and I haven't heard you -- you didn't say anything else today that would cause some concern, but you answered that in response to is there anything you think you need to tell us that you think we may need to know.

JUROR NUMBER 9: That was -- yes, I think that is something that you need to know.

THE COURT: Okay. Questions by the State.

MR. BROWN: No, Your Honor.

THE COURT: Questions by the Defense.

MR. LANNING: Juror 9, when you first asked about it you said you felt like that other experience

in your life would have an impact on how you would consider mitigation evidence?

JUROR NUMBER 9: Um-hmm.

MR. LANNING: You were concerned enough about that that you brought it to everybody's attention.

JUROR NUMBER 9: Yes.

MR. LANNING: Now, obviously, we want jurors to have no preconceived notions or biases and the reason for that is in order to have a fair trial. Do you believe that you have that bias? That's not changed.

JUROR NUMBER 9: You know, I have a hard time within this process to be asked questions, I'm afraid to (unintelligible) something that I (unintelligible). That's the reason I say that.

MR. LANNING: That's why you brought it up to begin with.

JUROR NUMBER 9: To begin with that I do have a reservation of how that.

MR. LANNING: The ideal is what the Judge is talking about, being able to set aside those things, but it was important enough to you that you don't feel like you can do that, do you?

JUROR NUMBER 9: Without a hundred percent,
let's say that, no, I don't feel like that I can
because like if you're asking for a hundred percent

yes, I can do that, no, I can't a hundred percent.

MR. LANNING: And you also had situations where you were concerned about your ability to, I believe it was related to credibility of police officers or something in relation -- I believe your husband is an officer?

JUROR NUMBER 9: Was a military police officer years ago.

MR. LANNING: And there was some concern about that?

JUROR NUMBER 9: No, there was some concern for -- one of the first questions was how much, how much of the trial publicity and then the reason -- and then I thought it would be fair for me to know that when this first happened, the event first happened that I did -- I think I texted or e-mailed him to tell him that there was a deputy that was shot and it was just a few miles from where I work, you know, and he -- and when we hear about that, no matter, you know, it's in another part of country, when we hear about a police officer being shot (unintelligible). But I'm not -- I don't follow the police. I'm not -- I never looked up anything on the case or anything that wasn't on the TV. So, I know I'm not -- I don't -- I'm not a law enforcement

follower or stuff like (unintelligible)?

MR. LANNING: Okay. But in relation, you know, family may be and likely will be sitting throughout this proceeding, or sitting in the courtroom proceeding and that gives you cause or concern that you would be biased in favor of the State? Not as to guilt, I think you indicated --

JUROR NUMBER 9: Oh, I can -- the guilt or innocence I have no problem with.

MR. LANNING: But if we go to a penalty phase, that's where it becomes a problem?

JUROR NUMBER 9: Yes, sir, it would become a problem.

MR. LANNING: All right. Judge, apparently there's a stipulation.

THE COURT: Okay. Okay. Juror Number 9, I'm going to release you from being considered as a juror in this case.

JUROR NUMBER 9: Okay.

THE COURT: You have been released. If you'll report downstairs to the jury assembly room, they'll give you further information and send you on your way.

JUROR NUMBER 9: Okay.

THE COURT: Okay.

1 (Thereupon, Juror Number 9 exited the 2 courtroom.)

THE COURT: Okay. Juror Number 9, just for the record, has been released for cause. We can bring in Juror Number 17.

(Thereupon, Juror Number 17 was escorted into the courtroom by the court deputy and the proceedings were had as follows:)

THE COURT: Okay. Juror Number 17, you talked to us, you said there may be something that you think would be -- that we needed to know that perhaps should be discussed outside the presence of the other jury members. So, this is your opportunity.

TUROR NUMBER 17: Well, since it's been about two and half weeks since we went through the initial part and the one thing that I guess didn't hit me right away but after that day, the next day, after that I kind of realized and it really bothered me, I kind of feel as though I'm pretty much into the questions but I guess maybe in case I do get selected for the jury that I would want possibly to have a better explanation than I could come up with and that is during the questioning and all that, it seems like there wasn't much time given to the judgment phase and (unintelligible). It may have been just when

they were questioning me but an awful lot on the penalty phase and I guess I kind of got the impression is are they giving up on the sentence or the penalty phase.

THE COURT: Giving --

JUROR NUMBER 17: Worried about that, which doesn't make sense. I realized myself it doesn't make sense but I guess I did think about it for a few days and it kind of, you know, made me do a lot of thinking and. I know there's probably a better explanation than what I can come up on my own as to why I got that impression why they put so much emphasis on the sentencing phase.

THE COURT: The problem with this process is that they don't get to talk to you again. There is a guilt phase where the jury will decide the -- whether the defendant is guilty or not guilty of four counts. In the event there's a guilty verdict on Counts I, then we go into the penalty phase and the problem with the process is the State, nor the Defense, they can't ask you all those questions. It's not like we can do the first phase and then ask you all -- then stop and then ask you all these questions and move into the second phase, we have to use the procedure, the law requires that we use the same jury for both

•

and so they kind of have to put -- and I think we explained that a little bit and I think the Defense explained that a little bit, they kind of have to put the cart before the horse and it's all hypothetical.

In the event there is a guilty verdict on Count I, then we move into the penalty phase. I assure you that the guilt phase is as important to both parties, both sides, the State and the Defense, as the penalty phase and the penalty phase is only if we get there, but the only time that we have an opportunity to ask you about how you felt about all those things is now.

JUROR NUMBER 17: But I just wanted to clarify in my mind in case I do get selected, I didn't want that weighing on my mind that it's something that it was a good opportunity to bring it up when all the other jurors were here.

THE COURT: Well, I appreciate you being conscious that that may bring up questions in other jurors minds that we didn't want them to -- maybe they don't those concerns and maybe they would after you said it. So, I appreciate you bringing that up. But now that I've explained that to you, do you have any concerns now? Or you just wanted everyone to know that that was your thought process?

JUROR NUMBER 17: Well, that that was my

thought process and I really felt that there was an explanation that I wasn't seeing because it didn't make sense for them to kind of, you know, forget the first part of the trial and I just didn't want to be swayed because of feeling that at one point in time I fell like I kind of gave up on the --

more on the first part of the trial and the reason we have to ask you those individually, and I did it in the beginning, was because -- I did the knowledge of the case and the death penalty in the beginning because I knew that that would -- we would have to -- I mean, those are issues that may cause jurors not to be fair and impartial. So, I did that in the beginning rather than do -- we did that first and then now we're kind of going back to where we would normally go on a trial because I didn't want to have -- there was -- you know, I knew that there would be less numbers to do the other part now, less numbers of jurors.

JUROR NUMBER 17: Okay.

THE COURT: So, we did that -- we kind of did that first because I knew that there would be a lot of people that would not be able to serve as a result of those two issues, and that's not unusual in any

case when you have those type of issues. Does that cause you any concern with regard to your service at this time?

JUROR NUMBER 17: No, because I think that's what it was, it didn't make sense to me that I was feeling that way and be a good explanation for it and I didn't want it to weigh on me. So, that's why I wanted to talk about it so I understand it if I was selected that that wouldn't be an influence.

THE COURT: Okay. Do you think -- now with that explanation, would that be an influence on your ability to serve?

JUROR NUMBER 17: No, I think I understand why now.

MR. MOORE: There was the other case, a similar case that we didn't get into which I didn't realize it was a similar case by this gentleman, that he was on ten years ago.

THE COURT: Okay. State wish to inquire?

JUROR NUMBER 17: Ten to twelve.

THE COURT: We didn't get into it because I thought that was more appropriate for the -- I mean, I didn't know it was a similar case. I knew he had been on a jury before (unintelligible). If you want to address -- talk to him about it now, you can.

MR. MOORE: Okay. Let me just follow up on the Court's comments. The comparison I would make it to is like wearing a seat belt, you know, and that is you don't -- when you get in the car you don't plan to get in a wreck, but if you do get in a wreck you better have a seat belt. It's a precaution and you may or may not need it and that's what I -- the comparison that I make with spending as much time as we did to add to what the Judge said.

JUROR NUMBER 17: Well, it's kind (unintelligible) to make sure that I would make a decision.

Now, can you tell me, if you will, please, about this other case that you were on ten years ago that was similar.

JUROR NUMBER 17: It was, it was a murder trial, there was two defendants, they had dropped the death penalty for the male (unintelligible) and they were both convicted.

MR. MOORE: But not for the female, they sought the death penalty?

JUROR NUMBER 17: No, they didn't seek for

1 death for the female. THE COURT: They went after the death penalty 2 3 for the male? JUROR NUMBER 17: Right, they charged them both with first degree murder. 5 THE COURT: And they were tried at the same 6 7 time, same trial? JUROR NUMBER 17: They were going to try and 8 separate because of the death penalty but then they joined trials. 10 MR. MOORE: You sat on that jury? 11 JUROR NUMBER 17: Yes. 12 MR. MOORE: Were you foreman of that jury? 13 JUROR NUMBER 17: No. 14 MR. MOORE: Did you reach a verdict? 15 JUROR NUMBER 17: Yes. 16 MR. MOORE: Anything about that experience, 17 similarities, of course, would be different maybe 18 some of the laws though. 19 JUROR NUMBER 17: It wasn't really that 20 similar, it was basically the murder of a two year 21 old and neglect and abuse. So, you know, totally 22 different circumstances. 23 MR. MOORE: Did you get to the penalty phase? 24 JUROR NUMBER 17: No, because they took the 25

death penalty off the table.

MR. MOORE: All right. So, anything about that experience having sat on that jury that would give you pause or any problems siting on this jury, this murder?

JUROR NUMBER 17: No, it just -- like I said
earlier when you asked questions that we kind of had
two and a half weeks to think about it, I think
about -- because it's not a fun experience, you do
it, you do it because it's your right as a citizen
and I would not have a problem doing, but like I
said, when he asked about big decisions that I've
made (unintelligible) like I said for a couple of
months afterward, you think about it and it's
something that you've done that's very severe that's
affected two people for the rest of their life.
Every day I went over it I came up with the same
conclusion, did one thing (unintelligible). So, am I

Okay. Juror Number 105, you said THE COURT: that you -- there was a matter that you thought may be more appropriate to discuss without -- with us outside the presence of other jury members.

THE COURT: So, now's your opportunity.

JUROR NUMBER 105: Just something I (unintelligible) I guess the way I perceive things firsthand and just the line of questioning that we went through the first time around and kind of my take on the whole list of potential witnesses on how it only seems like, and this is not a belief, it's just, it just seems like that the whole case is predicated on just proving the aggravation, it's almost like the criminal part of the trial is almost like a done deal. Do I -- do I -- does that mean that would factor in a decision if I was on the panel, no, it wouldn't, it's just my perception of

One of the problems with the case -- I mean, with the system and the process is those questions have to be -- we can ask you some questions in front of everyone else and we can ask you -- some questions we asked you individually because we didn't want it to prejudice other peoples thinking by your answer, just like we brought you in here and so we had to ask you about the knowledge of the case and we had to ask you about the death penalty individually. I did that first instead of at the end because I knew that based on this case and based on the fact that we were dealing with the death penalty, that that may cause some people not eligible to serve.

JUROR NUMBER 105: Right.

THE COURT: And so because it takes longer, I mean, when you're dealing with a courtroom and people are asking questions, it was -- I did that first in order to kind of determine who was going to be here and -- I knew that I would lose a lot of people in that process and so I waited until the very end to go

through the second part of the trial, but today as you saw we focused more on the first part of the case as opposed to the second part of the case, and both attorneys, the only time they were ever going to -you know, the death penalty issue and the penalty phase only comes into play in the event there's a guilty verdict on Count I, but the Defense and the State, they don't get another opportunity to question you. They don't ever get an opportunity to question you on those because the jury serves for both phases. So, this was there opportunity to do this and they took advantage of it because that was the time that they had to, and because most people have strong feelings about the death penalty. Some have very strong feelings for and some have very strong feelings against and we had to determine that, you know, it's important.

JUROR NUMBER 105: And your explanation made sense, it was --

THE COURT: Trying to put the cart before the horse.

JUROR NUMBER 105: The main factor for (unintelligible) was going to be that and so get it out and be done with the first thing but to pick a suitable set.

And so these are the ones we can do questions as a whole group.

JUROR NUMBER 105: Yeah.

THE COURT: So, we kind of -- I mean, in fairness that's my decision to do that and I kind ever put the cart before the horse. It's not -- I can understand why you may have thought that. Do you think that in any -- now that you've heard the explanation, I kind of --

JUROR NUMBER 105: I'm good, I'm good with how --

THE COURT: Yeah, I just got those issues out, those were the difficult issues, let's get those on table, let's get them addressed.

So, we address — then we want back to kind of the beginning. In a normal trial you would do all that first. And I say normal trial, a trial where you don't have — the death penalty is not an issue.
