**P&Z Recommendation**: Moia/Harber – Approved, with a Binding Development Plan embodying stipulations provided to the board from staff, and with the recommendations that the parking spaces on the west side of Friday Rd. at the corner between the gas station and the single-family residential zoning, be removed to preserve buffering, and that the masonry wall requirement be waived, with the requirement that the perimeter around any property abutting residential be either opaque wood or vinyl/PVC, and contingent upon the ordinance amending the CUP for Commercial Entertainment and Amusement Enterprises being approved by the BCC. Vote was unanimous.

V.B.12. (12PZ-00045) – COCOA EXPO SPORTS CENTER, LLC, AND UPLAND INVESTMENTS, LLC – (Jeffrey Unnerstall) – request a Small Scale Plan Amendment (12S.04) to change the FLU Map Designation from NC to CC; and a change from TR-1 & AU to BU-1 on 9.99 acres, more or less. Located on the north side of S.R. 520, approx. 180 ft. west side of Friday Rd., and also having frontage on the west side of Friday, north of S.R. 520. (no assigned address)

LPA Recommendation: Moia/Harber - Approved. Vote was unanimous.

**P&Z Recommendation**: Moia/Harber – Approved, with a Binding Development Plan embodying stipulations provided to the board from staff, and with the recommendations that the parking spaces on the west side of Friday Rd. at the corner between the gas station and the single-family residential zoning, be removed to preserve buffering, and that the masonry wall requirement be waived, with the requirement that the perimeter around any property abutting residential be either opaque wood or vinyl/PVC, and contingent upon the ordinance amending the CUP for Commercial Entertainment and Amusement Enterprises being approved by the BCC. Vote was unanimous.
