The area that is now Brevard County first appeared on a chart called the Cantino Map in 1502. The rendering of the New World showed a bump sticking out into the ocean. This bump became known as Capo de Canaveral or "Cape of the Wild Canes". It was most likely named by Spanish Captain Francisco Cordillo for the marsh grasses that covered the area.
