HISTORIC BREVARD

Marie Ringo Holderman was born in 1884, relocated to Cocoa in 1917 in response to an advertisement seeking someone to start an independent newspaper. Holderman subsequently founded the Cocoa Tribune, which continued to publish until 1967, when it was purchased by the Gannett Group of newspapers. Holderman's newspaper championed community improvements including bridges and roads. She lived in Cocoa until her death in 1968. Her Great Floridian plaque is at the Central Brevard Library and Reference Center, the former location of the Cocoa Tribune, at 308 Forrest Avenue, Cocoa.
