Good Afternoon Jackie,

As we discussed today, the rules of jurisdiction for unclaimed property were determined in the *Texas v. New Jersey* (1965) decision by the U.S. Supreme Court (http://supreme.justia.com/cases/federal/us/379/674/case.html). The state of the owner's last known address has jurisdiction over the unclaimed property. If the last known address is unknown or in a foreign country, then the property should be escheated to the state of incorporation for the organization.

Many states have reciprocity agreements whereby they can accept unclaimed property on behalf of other states. I have attached a copy of the reciprocity matrix to this email for your convenience. Please note Florida accepts only incidental property on behalf of other states. Incidental property is defined in Florida as 10 or fewer properties valued at \$1,000 or less. In addition, please be aware that Florida <u>cannot</u> indemnify a holder for any unclaimed property reportable to another state even if it is reported to Florida under a valid reciprocity agreement.

Per the reciprocity matrix, accounts from the following states would have to be refunded and reported directly to those states: CA, NJ, GA (over the incidental amount), OK (over the incidental amount), and VA (over the incidental amount). I recommend the amounts due to IN and NC be reported directly to the other states due to their size. However, if you still want Florida to accept them, I am checking with my administrator to see if Florida will accept the property reportable to IN and NC. Florida normally only accepts incidental property on behalf of other states. These states allow other states to accept on their behalf without limitation. I will let you know when I receive a response on this matter.
