## VIOLATION OF PROBATION FIRST ARRAIGNMENTS

- 1) All Violation of Probation charges/hearing dates shall be scheduled with the Judge or Division that placed the Defendant on probation.
- 2) Titusville VOP cases will be heard by the Judge covering County Court Misdemeanor cases in Titusville.
- 3) These hearing dates will be set on the next available VOP docket for each respective division as long as the date is **at least 10 days** from the date the warrant is served. If not, then the next VOP docket date shall be used for that division.

**PLEASE DO NOT ASSIGN A VIERA COURT DATE TO CASES WHICH SHOULD BE (OR WERE ORIGINALLY) ASSIGNED TO THE TITUSVILLE COURTHOUSE**
