VIERA COURTHOUSE- OCTOBER 2020 VIOLATION OF PROBATION FIRST ARRAIGNMENTS

All Violation of Probation charges/hearing dates shall be scheduled with the Judge or Division that placed the Defendant on probation. Titusville VOP cases will be heard by the Judge covering County Court Misdemeanor cases in Titusville and Melbourne VOP cases will be heard by the Judge covering County Court Misdemeanor cases in Melbourne. These hearing dates will be set on the next available VOP docket for each respective division as long as the date is **at least 10 days** from the date the warrant is served. If not, then the next VOP docket date shall be used for that division.

PLEASE: DO NOT ASSIGN A VIERA COURT DATE TO CASES WHICH SHOULD BE (OR WERE ORIGINALLY) ASSIGNED TO THE MELBOURNE OR TITUSVILLE COURTHOUSES VOP DATES: ALL TIMES ARE 9:00 AM UNLESS OTHERWISE NOTED
