RESPONSE TO NOTICE OF DISCOVERY
and
Demand for Notice of Intention to Claim Alibi

TO: OFFICE OF THE PUBLIC DEFENDER

PLAINTIFF, State of Florida, through the undersigned Assistant State Attorney, pursuant to Defendant's Demand for Discovery and pursuant to Rule 3.220 Florida Rules of Criminal Procedure, submits the following and hereby demands notice of intention to claim alibi:

Under Rule 3.200, Florida Rules of Criminal Procedure, if you intend to offer evidence of an alibi in your defense, you are hereby required to serve upon me, the undersigned Assistant State Attorney for the Eighteenth Judicial Circuit, in and for Brevard County, Florida, not less than ten (10) days before trial or at such time as the Court may direct, a notice in writing of your intention to claim alibi, which said notice shall contain specific information as to the place at which you claim to have been at the time of the alleged offense and, as particularly as it is known to you or your attorney, the names and addresses of the witnesses through whom you propose to establish such alibi. You are under a continuing duty to disclose promptly to me the names and addresses of any additional witnesses which may come to your attention subsequent to the filing of your witness list.

If you fail in any particular to comply with the provisions of said Rule 3.200 a motion will be made to exclude any and all evidence, except your own testimony, offered by you for the purpose of proving an alibi.
