These hearing dates will be set on the next available VOP docket for each respective division as long as the date is **at least 10 days** from the date the warrant is served. If not, then the next VOP docket date shall be used for that division.

PLEASE: DO NOT ASSIGN A VIERA COURT DATE TO CASES WHICH SHOULD BE (OR WERE ORIGINALLY) ASSIGNED TO THE TITUSVILLE COURTHOUSE.
