The user fees requested and recommended by the Melbournr-Tillman Water Control District's Board of Directors are not changed FY 2010-2011. The attached resolution presents the user fees as requested by the District's Board.

The following FY 2010-2011 rates apply:

Residential \$ 19.13 per lot or acre

Agriculture \$ 6.69 per lot or acre

Commercial \$ 37.14 per lot or acre

RESOLUTION NO. 10-

A RESOLUTION TO AUTHORIZE AND ADOPT USER FEES PURSUANT TO CHAPTER 86-418, FLORIDA STATUTES, AUTHORIZING THE BOARD OF THE MELBOURNE-TILLMAN WATER CONTROL DISTRICT TO LEVY USER FEES FOR FISCAL YEAR 2010-2011 AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 86-418, Florida Statutes, provides the authority for the Melbourne-Tillman Water control District to levy user fees; and

WHEREAS, the Melbourne-Tillman Water Control District is a dependent special district of the Brevard County Board of County Commissioners whose charges and budget are subject to the approval of the Brevard County Board of County Commissioners' and

WHEREAS, the user fees proposed by the Melbourne-Tillman Water Control District have been advertised and the subject of public hearings conducted by the Brevard County Board of County Commissioners on September 28, 2010; and

WHEREAS, the user fees to be levied and with no increase or decrease over current rates are stated in this resolution have been publicly read in full.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA, that:

1. The Board of Directors of the Melbourne-Tillman Water Control District has adopted the following classifications (categories of land use) to be assessed as follows:

CLASSIFICATION I, RESIDENTIAL -	\$19.13 per lot, acre or portion thereof
CLASSIFICATION II, AGRICULTURAL -	\$ 6.69 per lot, acre or portion thereof
CLASSIFICATION III, COMMERCIAL	\$ 37.14 per lot, acre or portion thereof

This levy has been adopted for the Budget of the District for the Fiscal Year beginning October 1, 2010, and ending September 30, 2011.

2. The aforementioned classifications and fees of the Melbourne-Tillman Water Control District are hereby ratified and affirmed for the Budget and Fiscal Year 2010-2011.
3. A certified copy of this resolution shall be filed with the Tax Collector of Brevard County, Florida.
4. This Resolution shall take effect immediately upon its adoption.
