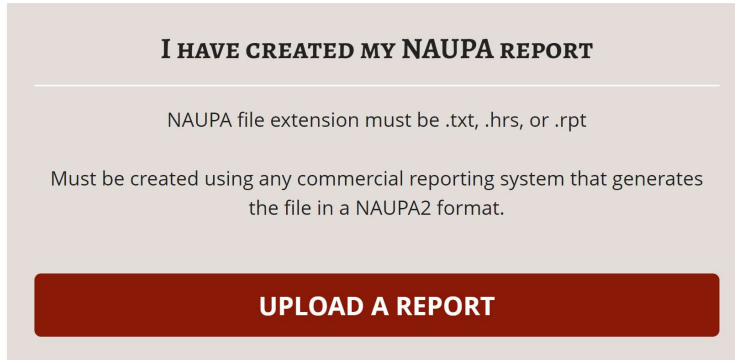

Filing required by holder: The report file is in the “TX” folder. Save the “.txt” file.

Holder must submit file through Texas website:

1. Download your .txt file and save outside of the .zip folder.
2. Go to the website here: <https://claimitexas.org/app/submit-a-report>
3. Select Upload a Report:




4. Enter company and contact information under “Primary Holder Info”
5. Enter Report Info
 - a. Report Type = Annual Report
 - b. Report Year = 2023
 - c. Your file is *not* a combined file, **unless you have requested it consolidated** through your MS Service Representative (all EIN/entities with UPE profile on one report.)
 - i. Parent Company FEIN will **NOT** be needed unless you requested a combined/consolidated report.
 - d. Skip Report ID section (nothing needed to be entered here.)
6. The upload screen will appear next. You will need to have saved a copy of the “.txt” file outside of the .zip folder, onto to your computer, in order to select it during upload. After uploading, click continue.
7. Payment coupon (Texas Payment Form) will arrive to Report Contact email address after submission.

Prepare a check (if paying by check) payable to ‘Texas Comptroller of Public Accounts – Unclaimed Property’.

When paying by check, print out and include the Texas payment form, which is sent directly to the report contact email.

To remit payments electronically with an automated clearinghouse (ACH) debit or credit, use the State of Texas Financial Network, TEXNET. You will need the “Core Report ID” from the Texas Payment form, found here:
