The Board has indicated a desire to discuss the CIP development and approval process.

Summary Explanation & Background:

For the past three (3) budget development cycles, the tentative CIP has been submitted to the Board concurrently with the tentative Operating and Capital Budget in July for approval in September.

The concurrent submittal and approval design was initiated primarily for the following reasons:

- a) To assist in providing the Board an overall picture of short- and long-term resource availability and needs both operating (including human resources) and capital.
- b) To allow the Board to address these needs during the same time period, as the needs often are inter-related both in terms of funding availability and impact upon the community.
- c) The first year of the CIP is included in the Annual Operating and Capital Budget.

For the FY 2005-2006 development cycle, the CIP was further refined to include only those items anticipated to be funded over the five-year period. Although projected needs continue to outweigh and outnumber the projected available funding, the inclusion of projects in the CIP that were not anticipated to be funded continued to have a detrimental impact on the County during discussion with rating agencies. The unfunded projects are now published in a separate report for the Board's information.
