Checks are no longer accepted. Payments made by check will be assessed penalties.

If you are unable to make an ACH debit or ACH credit payment, the only other option is by Fed wire. You can make this request by emailing ucp.holders@tn.gov. If approved, you will be sent the Fed wire instructions.

ACH Debit and Credit are available on the state website. Payment should be made when file is uploaded to TN website. Instructions can be found in the user manual, on page 11.
