

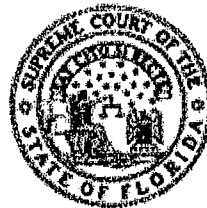
The trial court clerk is directed, on or before October 17, 2014, to supplement the record with the transcripts.

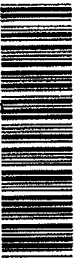

MOTION TO SUPPLEMENT RECORD ON APPEAL

COMES NOW Appellee, State of Florida, by and through undersigned counsel, and moves this Court, pursuant to Rule 9.200 (e) of the *Florida Rules of Appellate Procedure*, for an order directing the court reporter below to transcribe the following listed hearings that were not included in the record on appeal and to include the accompanying Diskettes, and to further order the clerk of the court below to supplement the record on appeal with any missing transcripts and accompanying Diskettes, including but not limited to:

- 1) All Voir Dire proceedings;
- 2) Any other hearing, docket sounding, pre-trial conference, portion of trial or sentencing that was not already designated to be transcribed as it pertains to this case.

This Honorable Court indicated, in its Order dated July 21st, 2014, that the court reporter was to “transmit a copy of **all** transcripts” and that the record on appeal is to be “**complete.**” (Order at 2, 3) (emphasis supplied). However, the designation directed by the Office of the Public Defender in the Eighteenth Judicial Circuit filed on May 13th, 2014, is incomplete and inadequate. This designation only directs that certain portions of the complete record be transcribed in opposition to this Court’s order. Previous efforts to address these deficiencies with the Public Defender for the Eighteenth Judicial Circuit have been unsuccessful.


The purpose of this motion is not to delay the proceedings or to accrue undue expense. However, the record on appeal must be complete, both for the effectiveness of appellate counsel and to ensure the accuracy and finality of future proceedings.

Undersigned counsel has spoken to opposing appellate counsel Christopher Quarles who does not object to this Motion.

WHEREFORE, the State of Florida, through undersigned counsel, respectfully requests that the Court direct the court reporter below to transcribe the aforementioned portions of trial and to provide them in sequentially numbered volumes of a supplemental record, and to further order the clerk of the court below to supplement the record with the transcripts and accompanying diskettes and provide copies to the parties and the Court.


