**IN RE: DOMESTIC VIOLENCE INJUNCTIONS (F.S. 741.30 [1995]) - REPEAT
VIOLENCE INJUNCTIONS (F.S. 784.046 [1995]): New Allegations of
Violence After Initial Case Dismissed**

WHEREAS, Domestic Violence Injunctions are filed in accordance with §741.30, Florida Statute (1995), and Repeat Violence Injunctions in accordance with §784.046, Florida Statute (1995), and

WHEREAS, Petitions for Domestic Violence Injunctions and Repeat Violence Injunctions are dissolved or dismissed for various reasons, and

WHEREAS, new Domestic Violence Injunction or Repeat Violence Injunction requests are made based upon allegations subsequent to the dismissal of the Domestic Violence Injunction or Repeat Violence Injunction, and

WHEREAS, supplemental filings occur only when judicial labor has not ended on the original case filed, and

WHEREAS, new allegations require an initial petition for Domestic Violence Injunction and Repeat Violence Injunction, because it is not a supplemental proceeding, as may be contemplated under Rule 1.110(h), Florida Rules of Civil Procedure, and

WHEREAS, in accordance with §741.30(h), F.S.(1995), mutual orders of protection are prohibited, and a separate Injunction for Domestic or Repeat Violence may be issued upon compliance with the provisions of F.S. 741.30, and therefore, there shall be no Counter-Petitions for Domestic Violence Injunctions or Repeat Violence Injunctions, but a separate Petition for a Domestic Violence Injunction or Repeat Violence Injunction.

NOW THEREFORE, any domestic violence allegation or repeat violence allegation after the injunction has been issued, denied or dismissed shall be determined to be an original filing and not be considered a supplemental filing.

AND THEREFORE, there shall not be counter-petitions in a domestic violence or repeat violence injunction file, but a separate petition for domestic violence or repeat violence filed.

All files involving the same parties, whether denominated initial petition for domestic violence injunction, supplemental petition for domestic violence injunction, regardless of the party who is the petitioner shall be presented to the court when any matter is brought before it.
