Re: Brevard County Pretrial Release Annual Report

The following report is submitted as statutorily required under Section 907.043, Florida Statutes. Reported information was recovered, researched and recorded by accessing data from the Pretrial Release register, the Professional Probation Services automated system (Probation Tracker) and the Brevard County Clerk of Court's e-facts criminal case tracking system. **Where it is known**, the following data is submitted in combination of Professional Probation Services, Inc. (**PPS**) and Brevard County Community Corrections (**BCCC**) for the reporting period of 01/01/2023 through 12/31/2023.

The Brevard County Pretrial Release Program services are provided and administered by contract through Professional Probation Services, Inc. The program operates at the Brevard County Jail Complex, 860 Camp Rd., Cocoa, FL 32927, (321)690-1514. It is the first privately operated Pretrial Program in the State of Florida.
