# HISTORIC BREVARD

As more permanent settlers arrived in the area, social and fraternal organizations also sprung up, including the Masons, Eastern Star, Knights of Pythias and the YMCA. Other lesser known groups also abounded. A different kind of society was the Independent Order of Truthtellers organized in Titusville in 1894. Blackballed by that organization, Arthur Doyle founded an opposing group known as the 'Ancient, Reckless, and Independent Order of Prevaricators.

They met at the same hotel as the Truthtellers, across the hall at the same time.
