JURY TRIAL PENALTY PHASE WAS HELD. JURY PROVIDED ADVISORY SENTENCE TO THE COURT, BY A MAJORITY VOTE, TO ADVISE AND RECOMMEND TO THE COURT THAT IT IMPOSE THE DEATH PENALTY UPON THE DEFENDANT. 
