All proceedings in this case have been transcribed and filed with the Clerk's Office in addition to the appellate record prepared as directed by the Supreme Court of Florida's order of July 21, 2014, with the exception of the entire voir dire that the Supreme Court of Florida directed on September 17, 2014, to be transcribed on or before October 7, 2014. Ms. Goin stated that Ryan Reporting had previously transcribed just a portion of the voir dire per the directions of the Public Defender's Office. Due to an extensive voir dire proceeding lasting at least two weeks in this case, Ms. Goin with Ryan Reporting expressed great doubt that the transcript would be completed by October 7, 2014. Ms. Kircher indicated that the Attorney General's Office would request an extension of time with the Supreme Court of Florida for completion of the voir dire transcript should the transcript not be completed by October 7, 2014. This Court ordered that the Public Defender's Office

be responsible for the costs associated with the transcription of the entirety of the voir dire proceeding in this case.


