**TRIAL COURT'S STATUS REPORT ON RECORD
CLARIFICATION**

Pursuant to the Order of the Supreme Court of Florida on February 11, 2015, that relinquished jurisdiction to the Trial Court to clarify the record, the undersigned judge submits this Report detailing the current status of clarification of the record for purposes of a direct appeal in this case.

On February 20, 2014, the undersigned judge conducted a status conference. Those present in person at the status conference included:

Kevin C. McBride, Esq., Staff Counsel for the Clerk of Court's Office; Kimberly Barding, Appellate Deputy Clerk for the Clerk of Court's Office; Carol Goin, owner of Ryan Reporting; James McMaster, Esq., Assistant State Attorney; Tom Brown, Esq., Assistant State Attorney; Michael Mario Pirolo, Esq., Assistant Public Defender; Michael Kazoroski, Director of the Digital Court Reporting Office in the Eighteenth Judicial Circuit; Rebecca Granger, Digital Court Reporter in the Eighteenth Judicial Circuit; and Mark Van Bever, Court Administrator for the Eighteenth Judicial Circuit. Stacey Kircher, Esq., Assistant Attorney General, and Christopher S. Quarles, Esq., Assistant Public Defender representing the Defendant on the direct appeal appeared by phone.

a. Michael Kazoroski testified that "Blue Man" was not used to record the Defendant's proceedings in this case, but rather the Digital Reporting Office utilized the open court recording software produced by the State of Florida.

b. Mr. Kazoroski testified that he listened to the digital recordings referenced in the Defendant's motion to clarify the record, and that the digital recording equipment did in fact clearly pick up the audio from most portions of the voir dire transcript and opening argument that the court

reporter erroneously designated as “unintelligible.” Ms. Goin represented that it was her office’s error.

c. Ms. Goin stated that she previously provided two transcripts of the voir dire: the first being a transcript of the jurors who were ultimately seated as jurors and the second transcript of the jurors who were not seated as jurors. Ms. Goin explained that she provided the transcripts in this fashion, because the requests were made separately. Ms. Goin explained that is why the two transcripts are disjointed. Ms. Goin agreed to provide one transcript of the entire voir dire proceeding that is organized chronologically and is complete. Ms. Goin represented that she could have this finished in four to six weeks.

Accordingly, it is **ORDERED**:

1. Ryan Reporting is to provide one transcript of the voir dire proceedings in this case which is complete in its entirety and organized chronologically. Ryan Reporting is to work with the Digital Reporting Office in the Eighteenth Judicial Circuit to obtain all digital recordings needed to complete this task so that all of the audio is transcribed.

2. Any cost for this transcription shall be paid by the Public Defender's Office. If the Public Defender's Office and Ryan Reporting cannot agree to the cost, the Court reserves jurisdiction on this issue.

3. The next status conference on this matter will be **April 8, 2015**, at **1:15 P.M.** A separate Notice of Hearing will not be issued.


