If not, then the next VOP docket date shall be used for that division.

PLEASE: DO NOT ASSIGN A VIERA COURT DATE TO CASES WHICH SHOULD BE (OR WERE ORIGINALLY) ASSIGNED TO THE TITUSVILLE COURTHOUSE.
